

## Terms of payment of skon kinderopvang

These Terms of Payment constitute a whole with the General Terms and Conditions for Childcare.

- a. For each child the contractor concludes a childcare contract with skon that stipulates the childcare period and the fee. The agreed placement concerns a certain location and a certain number of days of childcare per week, in accordance with the opening hours of the centre.  
If the fee, the location, the duration and/or use changes, the contractor will receive a new, adjusted proposal/contract, incorporating the change concerned.
- b. A proposal/contract can only be processed by skon, if the bank account number of the contractor is stated.
- c. The fee will be charged monthly in equal instalments, regardless of the actual number of childcare days in that month.
- d. Skon will debit the account of the contractor directly with the monthly instalment due between the 15<sup>th</sup> and 25<sup>th</sup> day of each childcare month.
- e. If a direct debit order is refused or reversed, the contractor must make the payment him/herself immediately. In the event of a refused or reversed direct debit order, skon will be entitled to charge € 10.00 for administrative expenses.
- f. If the contractor fails to meet his/her contractual obligations, skon reserves the right to suspend the childcare. The child to which this contract pertains, will then be denied access to the childcare centre concerned. If the contractor fails to meet his/her payment obligations, skon will also be entitled to exercise its right to terminate this agreement. If skon decides to terminate the contract because of the contractor's non-compliance, skon will observe the agreed notice period. The contractor will be obliged to pay the costs of childcare during the notice period.
- g. The contractor may cancel the contract in writing until its effective date. In the case of cancellation the contractor will receive written confirmation. It is not possible to cancel the contract orally.  
The amount of the cancellation charges depends on the scope of the agreed use (number of days/half-days per month) and the date on which the placement is cancelled, subject to a minimum of € 80 in accordance with the following graduated scale:

**Number of days preceding the effective date**

Number of days preceding the effective date	Cancellation charges
more than 6 months	€ 0,-
2 - 6 months	€ 80,-
45-60 days	50% of the monthly fee
30-44 days	100% of the monthly fee
15-29 days	150% of the monthly fee
less than 15 days	200% of the monthly fee

The date of cancellation will be the date on which skon receives the written notice of cancellation.

- h. After the effective date the contract can only be terminated in writing (by email to: [planning@skon.nl](mailto:planning@skon.nl)).  
The notice period is 2 months, from the 15<sup>th</sup> of a month or the last day of a month.
- i. When a contract for after school childcare is signed for a child that visits a school from which skon does not collect children, the contractors should arrange the transportation from school to the skon location their selves.
- j. These terms and conditions apply to each agreement and each offer and/or proposal between skon and the contractor, unless the Parties have agreed otherwise in writing.
